About LCHA

- LCHA was established in 1946
- LCHA provides rent opportunities and assistance for over
 3,600 individuals and families residing in Lake County
- LCHA is the **fourth largest** housing authority in the state of Illinois and the **largest** of the 3 that service Lake County
- LCHA supports housing needs for over 13,000 citizens of Lake County through its diverse programming
- LCHA has been a **non-smoking agency** since 2012
- Individuals and/or families in the low-rent and public housing programs (Section 8) pay at least 30% of their household income for rent; the difference is subsidized by the United States Department of Housing and Urban Development (HUD)
- LCHA is governed by a Board of Commissioners consisting of 7 members appointed to a 5 year term
- LCHA employs over 50 staff members

LCHA Affordable Housing Acquisition & Rentals Program

Fostering affordable housing opportunities by obtaining and rehabilitating HUD foreclosures, and then utilizing them to house additional families. Once purchased and rehabilitated, the homes are taken under the rentals inventory umbrella.

- 16 Homes have been purchased in the LCHA Affordable Rehab Program (located throughout the county)
- Currently, there are 31 properties in the rentals program inventory, which consists of various single family homes and lots throughout the county
- 8 Homes have been completely renovated since the program's inception in 2012, totaling approximately \$699,442, including the project collaboration with LCHA Technology Campus



- This program is funded using non-federal dollars
- The **ultimate goal** of this program is to transition these properties into **"homeownership" properties**

Low Rent Public Housing Program

- Owns and operates **7 buildings, totaling 332 units** of housing developed for **seniors** (55 & older) and **disabled** individuals
- Maintains **161 single family homes** throughout Lake County
- As of 12/29/2017 the average household income is \$15,691 and average tenant rent is \$249
- 49% of households headed by persons over 62 years-of-age
- 45% of households headed by persons with disability

Housing Choice Voucher (HCV) **Program** (Section 8)

- **Provides rent assistance** in privately owned rental units for low income individuals and families
- Federal funding allows LCHA to assist approximately 3,076 households with Housing Choice Vouchers. These vouchers assist approximately 7,000 individuals
- As of 12/29/2017, the average household income is \$15,951 and average tenant rent is \$280
- 37% of households are headed by persons with disability
- Average of **30 voucher turnovers** per month

Waiting Lists as of 12/29/2017

- 4,800 individuals/families are on the LCHA Housing Choice Voucher waiting list
- Combined total of 4,114 applications on our 9 Low Rent Public Housing waiting lists
- LCHA's HCV Section 8 and Public Housing Waiting Lists are closed
- The Waiting List for senior Public Housing remains open for those aged 55 and over
- Preference is given to Head-of-Households who are residents of Lake County, veterans, or currently residing in nursing homes



HOUSING CHOICE VOUCHER Program

Service Above All Else - Assisting Lake County Residents

Who We Serve

Lake County Housing Authority services all segments of the low-moderate income population, in addition to collaborations with **Chicago Regional Housing Initiative and State Referral Network**. In 2017, LCHA's Housing Choice Voucher Program (HCV) assisted over **3,000 families** averaging to approximately **7,000 individuals**. We also administered **294 Project Based Vouchers**.

Chicago Regional Housing Initiative (RHI)

LCHA currently works with **9 neighboring Housing Authorities** to combine efforts in housing families in need. Lake County now has **4 developments** that include **11 units** that offer project-based rental assistance. The developments include units that serve **special needs families** such as those experiencing **domestic violence and disabled families**.

State Referral Network

LCHA is working directly with the **State of Illinois** and the **Lake County Health Department** to help disabled who are affected by the 3 **Olmstead classes** that are subject to **Consent Decrees**. HUD has granted LCHA permission to help these members of the Consent Decrees, receive Housing Choice Vouchers so they can continue to maintain their quality of life. We have entered into an agreement with our **neighboring Housing Authorities, North Chicago and Waukegan,** to allow LCHA to administer the **SRN Vouchers** in their jurisdictions.

Family Unification Program (FUP)


The Family Unification Program (FUP) is a **Department of Housing and Urban Development (HUD) Section 8/Housing Choice Voucher Program** that brings the **Public Child Welfare Agency (PCWA)** and housing professionals together to work toward providing access to safe, decent, affordable housing for families who have been separated from their children, or are at risk of separation due to domestic violence, homelessness or the lack of adequate housing.

All Families must meet eligibility requirements of both PCWA, FUP and Lake County Housing Authority, in order to qualify. Contact our Housing Counseling Department for more information.

C.H.O.I.C.E.S.

(Choosing Housing Options In Communities Empowering Self-Sufficiency) The C.H.O.I.C.E.S. program was developed in an effort to diversify housing options for participants of the Housing Choice Voucher Program. LCHA recognized the tendency of clients to lease up in areas that are heavily concentrated with housing subsidy and poverty. The program encourages participants to move to communities that empower self-sufficiency, leading to a deconcentration of subsidized housing in communities that are already heavily impacted by poverty.

Who We Serve

Lake County Housing Authority's Public Housing
Program provides decent, safe, and sanitary
housing options for eligible low-income families, the
elderly, or persons with disabilities. LCHA has a variety
of public housing options for citizens to utilize, ranging
from scattered sites and single family homes to senior
citizen and disabled residential apartment communities.
There are approximately 5,232 Applicants on the waiting
list. The U.S. Department of Housing and Urban Development
(HUD) administers Federal funding to local housing agencies
to manage the housing for low-income residents at rental
standards that the population can afford.


Senior & Disabled Housing

Lake County Housing Authority maintains **273 units** of housing developed for **senior citizens** and persons with **disabilities**. Senior housing typically includes one studio, one and two bedroom apartments, and accessible one bedroom units. A single bedroom unit contains approximately **550 square feet of living space**.

Scattered Sites

LCHA currently owns and operates a **125 unit townhome** development, in addition to **163 single family housing units** scattered throughout Lake County. These scattered site homes help to **integrate** neighborhoods with higher incomes and deconcentrate low-income families from communities with limited growth and economic opportunity, placing them in the **optimum position for self-sufficiency**.



2017 Fiscal Audit

LCHA closed out the 2017 fiscal year with yet another successful audit report. It is extremely important that LCHA continues with the 10 year trend of having no audit findings. Our fiscal 2017 audit was yet another tribute to that philosophy. Excellence is key at LCHA and our intention is to continue with that trend throughout our service to the community as well as with our annual audit results.

2017 Net Position

Lake County Housing Authority's unrestricted net position was \$8,723,185 at fiscal year end. The increase in net position is primarily attributed to increased funding levels throughout the fiscal year. The favorable unrestricted funds balance allows the PHA to continue to meet on going housing obligations.

MARION JONES Redevelopment

Brookstone & Regency at Coles Park

The Marion Jones Townhomes were one of the oldest public housing complexes in the state of Illinois. Built in 1962, the complex supported a great portion of the low-income families in the city of North Chicago. Despite its presence as a housing staple in the county - the physical condition, building systems, and infrastructure of the buildings had reached the end of their useful life.

In 2013, **The Board of Directors and Executive Director/CEO David A. Northern, Sr.,** recognized the need to revitalize this property into a community that was not only more aesthetically pleasing, but also created housing equity for low-income families across Lake County.

In 2017 Lake County Housing Authority broke ground on the 49 million dollar housing development intended to replace the Marion Jones Complex that once provided housing for some of the county's most vulnerable citizens.

& REGENCY at Coles Park

The Regency at Coles Park has been designed to house 50 senior citizens. This development includes a courtyard as well as a library. Lake County Housing reports the estimated completion of this project is 26%.


Brookstone at Coles Park has been designed as a 170-unit development for multi-families. It will be complete with a kids' lounge, meeting spaces, and a playground. The estimated completion of this development is 15%. In addition to the amenities explained above, **both developments** will be complete with a computer lab and a fitness center for tenants to utilize.



Capital Improvements, Modernization & Asset Management



The Asset Management, Capital Improvements and Modernization Team, completed over **31 construction projects**, totaling approximately **\$80,000 in work**. The projects encompassed a broad range - from simple unit repairs to full unit turnaround and major building rehab. Approximately **25 units** were rehabbed under **full modernization**, with many others receiving **repairs and efficiency updates**.



Major Legal Victory

Despite long-standing opposition of homeowners and residents, LCHA won a major legal victory in the fight to transition Midlothian Manor in unincorporated Lake Zurich into a **14-unit building** that serves chronically homeless individuals with **mental illnesses.** In the coming months LCHA will be looking to partner with organizations who may help carry out the delivery of this essential service.





Family SELF-SUFFICIENCY

The Family Self–Sufficiency (FSS) Program is a voluntary program for participants who receive **HUD Housing Choice Voucher** (Section 8) **Rental Assistance**, or are living in **Public Housing**, and wish to improve their financial situation, eliminate their dependence on public assistance and are motivated to change their lives. It can be considered a bridge that connects individuals and families to their independence and goals of being self-supporting, by providing resources and supportive services along the way. The program emphasizes **employment** as well as **educational and vocational training** that leads to full time consistent employment.



FSS Graduation Ceremony

On November 4, 2017, FSS held a graduation ceremony to celebrate and acknowledge the accomplishments of their most recent graduates. Guest Speakers featured Chief Jennifer Witherspoon of the Lake County Sheriff's Office, and Former FSS Graduate Sherwina Adams, who delivered a powerful message on how she overcame seemingly impossible obstacles.

Lake County Housing Authority's Family Self-Sufficiency Program launched a literacy campaign that encompassed **4 events** for 2017.

The Purpose

of this campaign was to combat generational dependency on public housing services by implementing literacy skills at an earlier age.

We toured children around the **LCHA Grayslake Main Office** while explaining the importance of literacy in each department of the agency. FSS children received the opportunity to meet some of our leadership team members and staff to gain a better understanding of what we all do for the community, and how reading is the connector of all our services. We partnered with **Boys & Girls Club of Lake County**, who ran groups of literacy focused games throughout the evening for our guests to enjoy. We also facilitated a community book swap, to which **Grayslake Library** donated over 500 children's and adult books. They were also onsite to register **Round Lake** and **Grayslake** residents for library cards.

Additional FSS Programs & Services: Financial Literacy Workshops

HOUSING FOR HOPE Miata's Story

I was born and raised in Liberia - A small West African country founded by freed Black-American slaves in the 1800's. After Liberia was established in the 1800's, indigenous people of the country struggled to regain power for years, and as a result, war and violence broke out among different political factions. The root of the uprising was inequality amongst the political parties, yet it eventually intertwined itself with the blood diamond crisis in Sierra Leone. As time went on,

tensions and animosity in Liberia came to a boiling point. Violent civil war broke out, destroying families, businesses and economic growth. It became normal for me to witness a friend or family member being executed as a result of their genetic predisposition.

My husband applied for a visa, so our family could come to the United States and start our lives over in a safe place. My entire family had been murdered during the civil war and I no longer had a mother or father.

Because so many people were trying to flee from the violence, we were extremely blessed to gain a visa to the United States.

The day we packed our bags to head to America, I finally had hope for a better life, or at the

very least, just peace. We vowed to make the most of this opportunity because we had no other choice. If we stayed in Liberia, it was certain that we would not survive the mass genocides.

Upon our arrival at the airport, my worst nightmare came to fruition, just minutes before we set forth on our voyage to freedom. My husband was caught and murdered by members of an opposition group. As painful as this event was for my children and I, we persisted as I knew my husband would have wanted. There was no choice but to board the airplane. I had no idea what I would do upon arrival. I had to stay strong for my children.

When we arrived in America, I experienced immense culture shock. I had no family for support. I felt embarrassed for not being able to provide for myself and my children. Truth is, nobody expected me to. Why would they? I was a refugee from Liberia. The perception that accompanied this factor of my life caused people to look at me as uneducated, unable, unwilling and damaged. I never allowed anyone's view of me to deter-

mine who I was and what I was capable of becoming. It never stopped me from aspiring to better myself.

After living in a shelter and getting help from the church I attended, someone told me about Lake County Housing Authority's Housing Choice Voucher Program. I applied for a housing voucher and was accepted into the program. I was able to utilize the program as a stepping stone to get me where I needed to be in life.

Shortly after I got housing, my certification specialist recommended that I utilize the services of the **Family Self-Sufficiency (FSS) Program at Lake County Housing Authority**. After joining the FSS Program, my case manager helped me view my life as what it could be, and not what it had been.

As a mother, I felt shame when the lights were turned off, when we didn't have food, or when my children could see their disadvantage from other children. The FSS Program helped bridge the gaps in my life that were holding me back from success. It gave me an opportunity to prove my capabilities, and helped improve nearly every aspect of my life.

They made sure my family didn't miss an opportunity for assistance, and for that I am grateful.

I began working at Robert Morris College as a kitchen aide. Although the pay was not much, I was humbled to have a job. I remember seeing the adult learners everyday and thinking "I can do this." I kept bussing tables everyday knowing that one day I would be sitting in the chair instead of cleaning it off.

Eventually, I enrolled in school and graduated from the FSS Program. As a result of the services rendered to me through Lake County Housing Authority, I have a bachelor's degree and master's degree in special education. I

purchased my very first home because of the FSS Program, and am now a special education teacher, working with high school aged learners with unique behavioral needs.

My life is a compilation of events that made me who I am, for without obstacles, I am not me. Everything I have gone through has prepared me for who I am today. It is important to remember your past and the events that changed your life, which caused you pain or broke you. They made you who you are, but you cannot live in those moments. They belong in the past for a reason.

I was able to find success because I used the adversity in my life to propel me forward.

I look at it this way: Oil spilled into the ocean is destructive. It can eliminate entire ecosystems. But if you put that very same compound in a car, it is an accelerant and can put that vehicle in motion. It is the same substance, but it's what you choose to do with it that makes the difference.





Enrichment OPPORTUNITIES



Trip to the Capitol

Our group watched government in action at the capitol building and even received the opportunity to go onto the senate floor and sit in their state senator seats. They also learned about their own roles in a representative democracy and the processes that are available to them to enact change in their communities. Senator Melinda Bush, Representative Rita Mayfield, and

Senator Sam Yingling greeted our group and spoke with them about what they are doing to support the district that we live in. In addition to the governmental functions, the group also received the opportunity to visit the old state capitol building and stand on the steps where **Barack Obama** announced his run for presidency. We also visited the Abraham Lincoln Presidential Museum, where the group learned about the life and legacy of President Abraham Lincoln.



Attacking Obesity In Lake County

Studies have shown a correlation between low family income and childhood obesity. Lake County Housing Authority took proactive measures to inform our participants and practice healthy lifestyle choices with them. LCHA hosted Family Fitness Night with Joiwithfitness Group Fitness Studio. In addition to hosting the event free of charge, Joiwithfitness also offered our participants a membership for 75% off of the normal price.

Youth Build Lake County

Lake County Housing Authority & Youth Build Lake County have partnered to provide paid internships to community youth. Internship provide real-world job training and experience. It also provides youth the opportunity to work with an experience supervisor to help **develop**, **train**, and mentor them in their career paths. These internships have the potential to develop into regular full time employment opportunities.

2017 Summer Camp

Lake County Housing Authority utilized enrichment funds to send 22 children from the Family Self-Sufficiency Program to Smarties Summer Camp. These children engaged in outdoor activities for 5 days with staff members and volunteers from Lake County Housing Authority. This unique opportunity provided children in underserved communities the opportunity to experience the world outside of their everyday lives. Participants of this program engaged in positive character building activities, while building positive relationships with adult mentors.



Housing **COUNSELING**

LCHA's Housing Counseling Program serves the needs of Lake County residents in various areas related to housing, including:

- Homebuyer Education
- Pre-Purchase Counseling
- Post-Purchase and Foreclosure Prevention
- Mortgage Default Counseling
- Financial and Budgeting Counseling
- Rental Counseling

Clients are assisted through both **one-on-one sessions and group workshops.** Throughout the year, LCHA hosted Fair Housing and Financial Group Workshops.
